
<u>The British Society of Prosthodontics Membership Survey 2013/14:</u> <u>Survey on Specialist Activity in NHS and Private Practice</u>

This survey was carried out in order to gain a better understanding of specialist activity of members of the British Society of Prosthodontics and potentially inform workforce planning for the future. The Society was initially asked whether it would be prepared to carry out a survey by the SAC in Restorative Dentistry and subsequently the Council agreed that there would be benefits in having a better understanding of the work patterns and backgrounds of its members.


The invitation letter sent to members of the Society is shown in Appendix 1 and the questionnaire itself is shown in Appendix 2. The administrator of the society held a database of members contacted (entire membership), in order to send reminders and ensure each member only completed the questionnaire once. The data was anonymised and entered into a spreadsheet by the administrator. The anonymised data was analysed by the Honorary Secretary.

The survey was carried out from November 2013 to January 2014. A total of 370 questionnaires were sent to the BSSPD membership by post. 138 completed questionnaires were returned which gave a response rate of 37.2%.

The majority of the respondents (73.2%) were male (Figure 1) and a variety of age groups were represented in the responses (Figure 2). 55.8% of respondents were under the age of 51 years of age and 18.8% were over 61 years of age.




The respondents indicated that they worked in a range of locations, however the majority were from London, the North West, Scotland or the South East (Figure 3). As will be evident on the bar chart, some respondents worked in more than one geographical area.




The majority (88.4%) of respondents qualified between 1970 and 2009 (Figure 4). 89.1% qualified from within the UK (Figure 5).







79% of the respondents (109 individuals) indicated that they had a postgraduate specialisation qualification (Figure 6). For a small number of respondents it was not possible to fully interpret their qualifications. This may have been for example that they might have qualified outside of the UK.




39.1% were not currently on the any of the GDC Specialist Lists and 34.1% were on 2 lists or more (Figure 7).




Eight percent of the respondents were already retired, 15.2% stated that they were due to retire within the next five years. The largest proportion of respondents (30.4%) stated that they were due to retire in more than 20 years (Figure 8).



26% of respondents worked in a mixture of NHS Hospital, Academic Hospital and Practice (36 respondents). 17.4% described their practice to be purely within NHS Hospital, 15.9% described their practice to be purely Private Practice, 13.8% described their practice to be purely within Academic Hospital and 10.8% stated that they worked in mixed NHS and Private Practice (Figure 9). Separately from the bar chart, 27 respondents (19.6%) stated that they worked specifically in Specialist Practice.







Just under half of respondents (48%) worked 5 days per week (Figure 10) and 60% worked 46-48 weeks per year (Figure 11).

114 respondents performed both fixed and removable prosthodontics (82.6%). Two respondents (1.4%) carries out fixed prosthodontics only, 5 respondents (3.6%) carried out removable prosthodontics only, ten respondents (7.2%) carried out neither fixed nor removable prosthodontics and the data was missing for 7 respondents (5.1%). The assumption is that those respondents who were carrying out no fixed or removable prosthodontics work were those that were retired.

97 respondents (70.3%) were involved in teaching. The level and aspects of teaching were varied as can be seen in Figures 12 and 13.





Overall the data suggest that many respondents work in a range of different roles and often in more than one setting. It was of particular interest to note that the largest proportion of respondents do not anticipate retiring for more than 20 years. This may well be a reflection of the age of members who participated, however it could also suggest the possibility that at least some respondents might see themselves working beyond what has been a traditional understanding of normal retirement ages. Finally it has to be acknowledged that although the results are of interest, the response rate of 37% will mean that at the present time the data can only allow a partial understanding to be gained of the work patterns and backgrounds of members of the BSSPD.
